ま え が き

商人ギルドや手工業仲間の研究に関心をよせ、その関係文献の調査研究に心がけて以来かなりのことである。その構想は、(1)ドイツ・ギルドに関するビブリオグラフィ、(2)イギリス・ギルドに関するビブリオグラフィ、(3)フランス・ギルドに関するビブリオグラフィ、(4)その他諸国のギルドに関するビブリオグラフィ、とに分かつことにしていた。

しかしてその第一部をなすドイツ・ギルドに関するものは Die spezielle Bibliographie über die Deutschen Gilden, Zünfte und Handwerke im allgemein. と題して、前任地の富山大学経済学部経済学会編「富大経済論集」(第六卷第三・四号——1961・III・1)に、さらにその追補 Addenda も同誌(第八卷第一号——1962・VII・10)に収載された。その文献数は前者が598、後者が326で、総計924に及んだ。

以下ここに収載するのは、その第二部をなすイギリス・ギルドに関するビブリオグラフィである。ヨーロッパの中でもイギリスは歴史研究の進歩した国民であり、この種の特定課題についての文献の調査を網羅的になすことは極めて困難である。それに加えて、新しい研究文献もつねに相ついで現われ

るので、一朝一夕には成しえられない性質のもではあるが、自他ともに後学のための一里塚の意味をもち、かつこれを一つの手懸りとして大方の叱正と増補とをお願い出来れば、まことに幸甚とする次第である。

あらゆる研究は、これまでの先学の研究業績を基礎にして、それに数頁を加え、いくばくの増改訂を附しつつ進められるものであることから、研究課題関係文献の調査は研究者にとって最も必要な課題の一つでなければならぬ。したがって従来の特定研究文献には、主として参考に資せられた文献の一覧を附せられているのを見るが、必ずしも網羅包括的とはいうことが出来ないようである。しかしてここに注意を喚起したいのは General (Allgemeine) Bibliography に対して Special (Spezielle) Bibliography の重要性と稀少性とである。研究の進展とともに、歴史一般から漸次に民族別、地域別、時代別に細分され、更にそれらを研究課題別に再編して、一層詳細かつ具体的にわたる必要があるのであるが、それに相応ずる特殊ビブリオグラフィは最も地味な調査に属し、言うべくして困難なことからして、それはどうも満足すべき状態ではないように思われる。附録としての特定課題の研究に資せられた参考文献のレファレンスは別として、特定課題を中心とした網羅的な Special Bibliography は研究に必要なにかかわらず、その作成と存在は極めて少ないのである。

この特殊ビブリオグラフィの構想調査においては、一般の国史、法制史、経済史、社会史、商業史、工業史、技術史、農業史などの中において主題関係の研究記述が包含される場合が多いが、特殊ビブリオグラフィであることから、それらをすべて除外している。また更に地方史、郷土史、市町村史などにも同様関係のものが多く包含されているが、これらもまた除外することとした。すなわち本主題たるギルドに直接的関係のある特殊文献のみを主体とするものである。

先ず便宜のために一連番号を附し、編著者名をゴチックであげ、ついで文献名を掲げ、後に出版印行の所在と年代を示すことを原則とした。配列は編

著者名による ABC 順によるが、編著者が不記又は不明のものについては [] を附し、便宜その中に地名、職業名又は関係の術語乃至は主要語をばやはりゴチックで入れて配列に便した。なお雑誌、叢書、論文集の如きものの中の一文献であるものには、その文献名の末尾に (P) を附加してこれを示した。その他普通の略語については、一般に使用されているものに従っている。
